COBRA DOORS 2000 LTD. – 10-YEAR LIMITED WARRANTY PROGRAM

Warranty Period:

- Year 1: Parts and labour (*labour does not include removal or reinstallation of the door system*)
- Years 2–10: Parts only (limited warranty) – Supply Only

Warranty Coverage:

Cobra Doors 2000 Ltd. warrants its door systems to be free from manufacturer defects in materials and workmanship for a period of ten (10) years from the date of purchase, provided that all recommended installation, painting, and maintenance procedures are properly followed. Proof of purchase necessary.

Disclaimers and Limitations

- This warranty covers defects in material and workmanship of the pre-hung door system only. Cobra Doors 2000 Ltd., does not cover any components used in the installation and/ or additions used on the pre-hung door system.
- This warranty does not cover damage or deterioration caused by: vandalism, fire or smoke, harmful liquids or the failure of any paint or coating applied after manufacturing.
- Any product modifications, including the installation of storm doors or other alterations outside normal use, will void this warranty. No representative, dealer, or agent of Cobra Doors 2000 Ltd. is authorized to extend or modify this warranty beyond what is written here. This warranty is void if the product is damaged due to improper installation, use, or maintenance, or if it has been altered in any way outside of normal use.

Glass Warranty

- Glass units are covered by a 10-year limited warranty for seal failure only.
- Glass breakage of any kind is not covered.
- Any glass defect must be visible from a distance of 1 meter (approximately 3 feet).

Exclusive Remedies and Claims Procedures:

The exclusive remedy for a product that does not perform as warranted is repaired or replaced. An authorized Cobra Doors Dealer shall inspect the product in question and shall determine whether repair or replacement will be authorized. Labour costs associated with removal or re-installation of the door system is solely the responsibility of the purchaser or homeowner.

This warranty is in lieu of all other warranties expressed or implied and shall be void if damage was due to improper installation maintenance or use. Warranty may be void when products are altered in any way other than normal use. Installation of a storm door on a Cobra door voids all warranties. All end users must contact their dealers directly regarding any warranty issues. Cobra Doors 2000 Ltd. will not deal directly with the end user, only with the authorized retailer.
